



CHICKEN: A domesticated fowl of the genus *Gallus* and species *G. gallus*.

CHICKEN COOP: Any structure used for the housing of chickens.

CHICKEN RUN: A fenced outside yard for the keeping and exercising of chickens.

POULTRY: A domesticated chicken fowl of the genus *Gallus* and species *G. gallus* and domesticated duck fowl of the Mallard (*Anas platyrhynchos*) and Muscovy Duck (*Cairina moschata*).

POULTRY COOP: Any structure used for the housing of poultry.

POULTRY RUN: A fenced outside yard for the keeping and exercising of poultry.

(a) **Chicken.** “Chicken” means a domesticated fowl of the genus *Gallus* and species *G. gallus*.

(b) **Chicken coop.** “Chicken coop” means a structure that houses chickens.

(c) **Chicken run.** “Chicken run” means a fenced outside yard in which to keep chickens and allow them to exercise.

(d) **Nuisance.** “Nuisance” includes an animal committing any of the following:

- 1) chasing vehicles;
- 2) fighting with other animals;
- 3) chasing and killing birds and other wildlife;
- 4) habitually or frequently making animal noises;
- 5) leaving excrement on public or private property;
- 6) molesting, defiling, or destroying public or private property;
- 7) frequenting school grounds, parks, or other public areas while unrestrained; or
- 8) annoying an individual not on the animal owner’s or custodian’s property.

(e) **Poultry.** “Poultry” means domesticated chicken fowl of the genus *Gallus* and species *G. gallus* and domesticated duck fowl of the Mallard (*Anas platyrhynchos*) and Muscovy (*Cairina moschata*) species.

(f) **Poultry coop.** “Poultry coop” means a structure that houses poultry.

(g) **Poultry run.** “Poultry run” means a fenced outside yard in which to keep poultry and allow them to exercise.

It shall be the responsibility of the owner or custodian of any animal in the city, whether permanently or temporarily therein, to prevent such animal from committing any act which constitutes a nuisance. It shall be considered a nuisance for any animal, including dogs, cats, ferrets and poultry, to habitually or frequently make animal noises including barking, crying, howling, meowing, whimpering, or clucking, or quacking; to frequent school grounds, parks or other public areas while unrestrained; to chase vehicles; to fight with other animals; to chase and kill birds or other wildlife; to annoy any person if such person is not on the property of the animal owner or custodian of the animal; to molest, defile, destroy any public or private property; or to leave excrement on any property, public or private.

An animal owner or custodian is responsible for preventing the owner's or custodian's animal from committing a nuisance in the city.
